### KYTC Preps For New Overlay Project

Several members of the Kentucky Transportation Cabinet’s Pavement Design team and a few engineers joined the KCA for a site visit to an Indiana concrete overlay project.

The project on SR161 (about an hour west of Louisville) was a 3 phase project that showed the durability of concrete overlays over the last 7 years, as well as the construction process for a phase being completed during

the visit. The project was a good overview of concrete overlays of asphalt pavements as it showed various design parameters (fiber vs non-reinforced, varied depths, etc.) for the consideration of those in attendance. ACPA’s Indiana Chapter representatives, Mike Beyers, and Patrick Long were in attendance to guide the tour and answer questions as well as provide insights.

The Cabinet employees and consulting engineers in attendance are part of the lead design team for the upcoming 5 mile concrete overlay on the Bluegrass Parkway in Elizabethtown, KY. They were very intrigued by the process and spent a significant amount of time discussing best practices with the contractors on site and the ACPA staff. The success of the Bluegrass Parkway Concrete Overlay could spell out a shift in the paving market for the state.

Of particular note to the Ready Mixed industry was the focus and promotion of the concrete overlay for local streets and roads during the trip. Another short visit to a local overlay project being completed showcased the concrete overlay as a versatile solution to many different paving needs.

In discussing the future of the Environmental Control & Safety Committee, it was unanimously agreed that the responsibilities of the committee were too important to the industry to suggest dissolving.
