### Membership Qualifications

1. Any individual or firm engaged in the production and/or sale of ready mixed concrete in the state of Kentucky is eligible to apply for **PRODUCER MEMBERSHIP** in the KCA.
2. Any individual or firm engaged in the construction, restoration, or repair of concrete pavements that have performed cumulative said work in excess of \$1 million on average annually for the preceding 5-year period in the state of Kentucky is eligible to apply for **CONCRETE PAVING CONTRACTOR MEMBERSHIP** in the KCA.
3. Any individual or firm providing services or supplies used by the ready mixed concrete industry in Kentucky is eligible to apply for **ASSOCIATE MEMBERSHIP** in the KCA.
4. Firms who conduct their business on a high ethical level and fulfill their contracts and obligations are eligible. KCA desires to develop a membership designed to assure skill, integrity, and responsibility.
5. All membership applications are subject to approval by the KCA Board of Directors.
6. Companies who have been a member and are rejoining the KCA will have to pay the dues for the prior two years to be eligible for the school, program, and event discounted rates. Companies who are joining KCA for the first time will be eligible for the discounted rate immediately.
